#### **Balloting**

Balloting will be used to determine the order of priority. The person(s) or company(ies) interested in purchasing any of the specified residential properties ("the registrant(s)") must follow the procedures below:-

#### 1. Staff Group (Group P)

- 1.1 Qualified staff group registrant ("qualified person(s)") means any director or full time staff (and his/her Immediate Family Member (Immediate Family Member of Group P registrant ("Immediate Family Member qualified person(s)") means a spouse, parent or child of that registrant Provided That the relevant supporting documents to the satisfaction of the Vendor must be provided to prove the relationship concerned and that the Vendor reserves the final right to decide whether or not such relationship exists)) of any of the following companies or any of its subsidiaries incorporated in Hong Kong:

The Vendor reserves its absolute right to determine whether or not a staff is a qualified person.

### 2. Group A and Group B

- 2.2 Each of the registrants (or his/her authorized person) must submit the following to L5, Mira Place One, 132 Nathan Road, Tsim Sha Tsui, Kowloon and / or 21/F, ONE IFC, Central, Hong Kong (collectively "the registration venue") during the period from 25 July 2020 to 30 July 2020 (from 10:30 a.m. to 8:00 p.m.) (The order of registration will not have any impact on the order of priority for selecting the residential property):
  - (a) a maximum of one (1) Group A Registration of Intent and one (1) Group B Registration of Intent duly completed and signed by the registrant. Duplicated submission will not be accepted; and
  - (b) the Registration of Intent shall be accompanied with cashier order(s).

Registrants submitting the Group P Registration of Intent, Group A Registration of Intent or Group B Registration of Intent (collectively the "Registration of Intent" and each a "Registration of Intent") will be divided into three (3) groups of balloting, i.e. Group P, Group A and Group B in accordance with the forms of the Registrations of Intent they submitted, to determine the order of priority for selection of the specified residential properties.
- 4. The cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the specified residential property.

#### (d) Staff Group (Group P)

- (i) Where a registrant selects only one specified residential property in respect of a Registration of Intent, the purchaser(s) of that specified residential property shall only be:
  - (1) That registrant; or

- (2) One or more "Immediate Family Members qualified person(s)" of that registrant whom that registrant requests the Vendor on spot to be the purchaser(s); or
- (3) That registrant together with one or more "Immediate Family Members qualified person(s)" of that registrant whom that registrant requests the Vendor on spot to add as joint purchaser(s).
- (ii) "Immediate Family Member qualified person(s)" of Group P registrant means a spouse, parent or child of that registrant. Purchasers have to bring along with the relevant valid supporting document(s) as a proof to the satisfaction of the Vendor.
- (iii) The Vendor reserves its absolute right to determine whether or not a participant is a qualified "Immediate Family Members qualified person(s)".

#### (e) Group A and Group B

- (i) Where a registrant selects only one specified residential property in respect of a Registration of Intent, the purchaser(s) of that specified residential property shall only be:
  - (1) That registrant; or
  - (2) That registrant together with one or more "Immediate Family Members" of that registrant whom that registrant requests the Vendor on spot to add as joint purchaser(s).
- (ii) Where a registrant selects more than one specified residential property in respect of a Registration of Intent:
  - (1) The purchaser(s) of at least one so selected specified residential property shall only be:

- (iv) The Vendor reserves its absolute right to determine whether or not a participant is a qualified "Immediate Family Members".
- 8. Group P Registration of Intent, Group A Registration of Intent and Group B Registration of Intent will be automatically applied to the 'Information on Sales Arrangements" (if any) in the Phase up to the designated period for the collection of the unused cashier order(s) stipulated in the "Information on Sales Arrangements".
- 9. A Registration of Intent shall become invalid if any of the following events shall happen:-
  - (a) The registrant(s) has already utilized the Registration of Intent to purchase the same number of specified residential property which the registrant(s) intends to purchase as indicated in the Registration of Intent.
