- F) 第一按揭貸款銀行須為賣方所指定及轉介之銀行，買方並須首先得到該銀行書面同意辦理第二按揭貸款。
First mortgagee bank shall be nominated and referred by the Vendor and the Purchaser shall obtain a prior written consent from the first mortgagee bank to apply for a second mortgage loan.

First mortgage loan and second mortgage loan shall be processed by the relevant mortgagees independently.

The second mortgage loan shall be secured by a second equitable mortgage and/or second legal mortgage over the specified residential property.

All stamp duties on the PASP, ASP and the assignment (including but without limitation any stamp duty on, if any, nomination or sub-sale, any ad valorem stamp duty, special stamp duty, buyer's stamp duty and additional stamp duty chargeable under the Stamp Duty Ordinance (Cap.117, Laws of Hong Kong), and any penalty, interest and surcharge, etc. for late payment of any stamp duty) shall be borne by the Purchaser.
