1. First come first served. In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential property to any interested person by any method (including balloting).

2. Subject to paragraph 3 below, the party(ies) interested in purchasing the specified residential properties (“**Interested Party**”) must attend the Sales Office to select and purchase the specified residential property and bring along (i) a cashier’s order in the sum of HK\$100,000 made payable to “Deacons” or “**的近律師行**” for the purchase of each specified residential property in payment of part of the initial deposit; (ii) blank cheque(s) for payment of the balance of the said initial deposit; (iii) (if the Interested Party is an individual) Hong Kong Identity Card or passport, OR (if the Interested Party is a corporation incorporated in Hong Kong) copy of its Business Registration Certificate, copy(ies) of the latest annual return and (if applicable) subsequent Form(s) ND2A, company chop, and copy of the Hong Kong Identity Card or passport of its director(s) who sign(s) the preliminary agreement for sale and purchase of the specified residential property so purchased ; and (iv) (if the Interested Party is unable to attend the Sales Office to purchase the specified residential property) the original Power of Attorney (in the Vendor’s prescribed form of Power of Attorney) duly executed by the Interested Party together with copy(ies) of the Interested Party’s identity document(s) or Business Registration Certificate (as the case may be) and the original identity document of such attorney.
