- (2) The Vendor does not undertake and is under no obligation to review, consider or accept the highest offer or any offer at all for the purchase of any specified residential property. The Vendor has absolute right to withdraw from the sale of any specified residential property at any time before the acceptance of any offer. - (4) Notwithstanding anything provided herein, in case a black rainstorm warning signal or a typhoon signal no.8 or above is announced or extreme conditions announcement is made and is still in effect after 9 a.m. on the closing date of the tender, the closing date and time of the tender will be extended to the next working day at 12 noon and in respect of which no black rainstorm warning signal or typhoon signal no.8 or above is announced or extreme conditions announcement is made. The above arrangements shall not affect the closing date and time of any subsequent tender exercise(s) under this sales arrangement. The Vendor reserves the right to reject the entry of any person into the Sales Office. Although a specified residential property may be available for tender on a date of sale, it may become unavailable during that date of sale because the Vendor may accept a tender within the relevant period after the close of a previous tender exercise as specified in the tender documents. In such event, the Vendor will reject other offer(s) for that specified residential property.
