Each individual and corporate registrant (whether in his/her/its own name or in joint names with any other party(ies)) can submit up to TWO (2) Registrations of Intent only. Any excess Registration of Intent will not be accepted.

1. Registrant(s) must submit the following to the 8 Observatory Road Venue at or before 6 p.m. on 11 January 2024 (“**the Deadline of Submission**”):-

- (i) Balloting will take place at about 7 p.m. on 12 January 2024. The ballot results, including “registration number”, “ballot result sequence” and “the check-in timeslot for registrants” will be posted at 8 Observatory Road Venue at or before 8 p.m. on 12 January 2024. Registrant(s) will not be separately notified of the ballot results.

Relevant supporting documents must be provided to the satisfaction of the Vendor to prove the relationship(s). The Vendor's determination as to whether there is such a relationship shall be final.
