1. 準買家應參閱發展項目的售樓說明書，以了解該項目的資料。

Prospective Purchasers are advised to refer to the sales brochure for the development for information on the development.

2. 根據《一手住宅物業銷售條例》第 52(1)條及第 53(2)及(3)條，-

According to sections 52(1) and 53(2) and (3) of the Residential Properties (First-hand Sales) Ordinance, -

第 52(1)條 / Section 52(1)

在某人就指明住宅物業與擁有人訂立臨時買賣合約（『臨時合約』）時，該人須向擁有人支付售價的 5%的臨時訂金。

A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase ("PASP") in respect of the specified residential property with the owner.

第 53(2)條 / Section 53(2)

如某人於某日期訂立臨時合約，並於該日期後的 5 個工作日內，就有關住宅物業簽立買賣合約，則擁有人必須在該日期後的 8 個工作日內，簽立該買賣合約。

If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the PASP, the owner must execute the agreement for sale and purchase within 8 working days after that date.

第 53(3)條 / Section 53(3)

如某人於某日期訂立臨時合約時，但沒有於該日期後的 5 個工作日內，就有關住宅物業簽立買賣合約，則 - (i) 該臨時合約即告終止；(ii) 有關的臨時訂金即予沒收；及 (iii) 擁有人不得就該人沒有簽立買賣合約而針對該人提出進一步申索。

If a person does not execute an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the PASP- (i) the preliminary agreement is terminated; (ii) the preliminary deposit is forfeited; and (iii) the owner does not have any further claim against the person for the failure.

3. 實用面積及屬該住宅物業其他指明項目的面積是按《一手住宅物業銷售條例》第 8 條及附表二第 2 部的計算得出的。

The saleable area and area of other specified items of the residential property are calculated in accordance with section 8 and Part 2 of Schedule 2 to the Residential Properties (First-hand Sales) Ordinance.

4. 註：於本第 4 段內，「售價」指本價單第二部份表中所列之住宅物業的售價，而「成交金額」指臨時合約中訂明的住宅物業的實際售價。因應不同支付條款及/或折扣按售價計算得出之價目，皆以四捨五入方式換算至千位數作為成交金額。

Note: In this paragraph 4, "Price" means the price of the residential property set out in Part 2 of this price list, and "Transaction Price" means the actual price of the residential property set out in the PASP. The Transaction Price is obtained by applying the relevant terms of payment and/or applicable discounts on the Price and rounded to the nearest thousand.

4(i). 支付條款 Terms of Payment

買方於簽署臨時合約時須繳付相等於成交金額 5%之金額作為臨時訂金。其中港幣\$50,000 之部分臨時訂金須以銀行本票繳付（除非賣方另外同意），臨時訂金餘額可以本票或支票支付，本票及支票抬頭請寫「高李葉律師行」或“KAO, LEE & YIP SOLICITORS”。

Upon signing the PASP, a preliminary deposit equivalent to 5% of the Transaction Price shall be paid by the Purchaser. Part of the preliminary deposit in the sum of HK\$50,000 must be paid by cashier order (unless the Vendor agrees otherwise) and the balance of the preliminary deposit may be paid by cashier order(s) or cheque(s). The cashier order(s) and cheque(s) should be made payable to " KAO, LEE & YIP SOLICITORS " or 「高李葉律師行」.

A. 120 天現金付款計劃 (照售價減 20%) 120 Days Cash Payment Plan (20% discount on the Price)

A preliminary deposit equivalent to 5% of the Transaction Price shall be paid upon signing of the PASP.

The balance of the Transaction Price (95% of the Transaction Price) shall be paid within 120 days after the date of the signing of the PASP.

2. 「宏地薈」會員折扣 “WO Club” Members Discount

如買方為宏地薈會員(即在簽署臨時合約當日或之前，最少一位個人買方(如買方是以個人名義)或最少一位買方之董事(如買方是以公司名義)為宏地薈會員，買方可獲 2%售價折扣優惠。

If the Purchaser is a WO Club member (i.e. at least one individual Purchaser (if the Purchaser is an individual) or at least one director of the Purchaser (if the Purchaser is a corporation) is a WO Club member on or before the date of signing of the PASP), the Purchaser will be offered 2% discount on the Price.

3. 「從價印花稅」折扣 “Ad Valorem Stamp Duty” Discount

買方可獲 3%售價折扣作為「從價印花稅」折扣。

3% discount on the Price would be offered to the Purchaser as the “Ad Valorem Stamp Duty” Discount.

4. 「提前減息優惠」折扣 “Early Interest Rate Cut” Discount

買方可獲 2%售價折扣作為「提前減息優惠」折扣。

2% discount on the Price would be offered to the Purchaser as the “Early Interest Rate Cut” Discount.

5. 「利東站旁」折扣 "Lei Tung Station" Discount

買方可獲 1%售價折扣作為「利東站旁」折扣。

1% discount on the Price would be offered to the Purchaser as the "Lei Tung Station" Discount.

6. 「即買即用」折扣 "Enjoy Now" Discount

買方可獲 2%售價折扣作為「即買即用」折扣。

2% discount on the Price would be offered to the Purchaser as the "Enjoy Now " Discount.

7. 傢俬現金津貼折扣 Furniture Subsidy Cash Discount

A. (只適用於選購本價單所列之 C 單位(19 樓 C 單位除外)或 D 單位之買方)

(Only applicable to the Purchaser who chooses to purchase Unit C (except Unit C on 19th Floor) or Unit D listed in this price list.)

(a) 如買方於簽署臨時合約時選擇傢俬現金津貼折扣，買方可獲港幣\$38,000售價折扣優惠。

If the Purchaser chooses the Furniture Subsidy Cash Discount upon the signing of PASP, the Purchaser will be offered HK\$38,000 discount on the Price.

(b) 如買方於簽署臨時合約時不選擇傢俬現金津貼折扣，則買方可享有第(4)(iii)2段所述之傢俬禮券優惠。為免疑問，就購買每個住宅物業，買方只可享有傢俬現金津貼折扣或第(4)(iii)2段所述之傢俬禮券優惠的其中一項。

If the Purchaser does not choose the Furniture Subsidy Cash Discount upon the signing of PASP, the Purchaser is entitled to the Furniture Voucher Benefit set out in paragraph (4)(iii)2. For the avoidance of doubt, for the purchase of each residential property, the Purchaser is only entitled to either the Furniture Subsidy Cash Discount or the Furniture Voucher Benefit as set out in paragraph (4)(iii)2.

B. 傢俬現金津貼折扣 Furniture Subsidy Cash Discount (只適用於選購本價單所列之 19 樓 C 單位之買方)

Furniture Subsidy Cash Discount (Only applicable to the Purchaser who chooses to purchase Unit C on 19th Floor listed in this price list.)

買方可獲港幣\$38,000 售價折扣優惠。

The Purchaser will be offered HK\$38,000 discount on the Price.

4(iii). 可就購買該項目中的指明住宅物業而連帶獲得的任何贈品、財務優惠或利益

Any gift, or any financial advantage or benefit, to be made available in connection with the purchase of a specified residential property in the development

1. 提前付清餘額現金回贈優惠 Early Settlement Cash Rebate Benefit

(只適用於選擇第 4(i)段中支付條款 A 之買方 Only applicable to the Purchasers who have selected Terms of Payment A in paragraph 4(i))

- (a) 如買方提前於買賣合約訂明的付款限期日之前付清成交金額餘額，可獲賣方根據以下列表格計算的「提前付清餘額現金回贈」(「現金回贈」):

Where the Purchaser settles the balance of the Transaction Price earlier than the due date of payment as specified in the agreement for sale and purchase, the Purchaser shall be entitled to an "Early Settlement Cash Rebate" ("Cash Rebate") payable by the Vendor in the amount and manner as set out in the table below :

- (b) 買方須於提前付清成交金額餘額日前最少 30 日，以書面通知賣方向賣方申請現金回贈，賣方於收到申請並確認有關資料無誤後，現金回贈將直接用作支付買方應繳付之部份成交金額餘額(或以其他由賣方決定的方式支付)。

The Purchaser shall apply to the Vendor in writing for the Cash Rebate at least 30 days before the date on which the whole balance of the Transaction Price is to be early paid. After the Vendor has received such application and duly verified the information, the Vendor will apply the Cash Rebate as part payment of the balance of the Transaction Price payable by the Purchaser directly (or in any other manner as the Vendor may decide).

- (c) 該優惠不能轉讓及轉移，及只能由買方本人行使及享用。

The benefit is non-assignable and non-transferable and can only be exercised and enjoyed by the Purchaser personally.

- (d) 該優惠受其他條款及細則約束。

The benefit is subject to other terms and conditions.

2. 傢俬禮券優惠 Furniture Voucher Benefit

(只適用於選購本價單所列之 C 單位(19 樓 C 單位除外)或 D 單位之買方)

(Only applicable to the Purchaser who chooses to purchase Unit C (except Unit C on 19th Floor) or Unit D listed in this price list.)

- (a) 傢俬禮券優惠(『該優惠』)由指定傢俬公司提供。

The Furniture Voucher Benefit (the “Benefit”) is provided by the designated furniture company.

- (b) 買方於簽署臨時合約時，可免費獲贈由指定傢俬公司提供價值為港幣\$38,000之傢俬禮券一張 (『該禮券』)。

Upon the signing of the PASP, the Purchaser will receive a HK\$38,000 furniture voucher (the “Voucher”) provided by the designated furniture company free of charge.

- (c) 買方須於簽署臨時合約後的7個工作日內兌換該禮券並與指定傢俬公司簽訂有關提供適用於指明住宅物業的指明傢俬(『該傢俬』)之合約。

The Purchaser shall redeem the Voucher within 7 working days after signing of the PASP and enter into a contract with the designated furniture company regarding the provision of specified furniture applicable to the specified residential property (the "Furniture").

- (d) 有關該傢俬的詳情(包括但不限於設計、顏色及物料)，請向指定傢俬公司查詢。

For details (including without limitation the design, colour and materials) of the Furniture, please enquire with the designated furniture company.

- (e) 若買方未能遵守、履行或符合臨時合約或買賣合約內任何條款或條件，賣方有權即時撤銷該優惠及/或向買方尋求退回該優惠，且並不損害賣方於臨時合約、買賣合約或其他適用法律下之其他權利及濟助。

In the event that the Purchaser fails to observe, perform or comply with any of the terms and conditions contained in the PASP or the agreement for sale and purchase, the Vendor shall be entitled to cancel the Benefit and/or ask the Purchaser for return of the Benefit forthwith without prejudice to the Vendor’s other rights and remedies under the PASP, the agreement for sale and purchase or other applicable laws.

- (f) 為免生疑問，買方須付清指明住宅物業之成交金額及按買賣合約完成指明住宅物業之買賣，不管：

For the avoidance of doubt, the Purchaser shall settle the full amount of the Transaction Price of the specified residential property and complete the sale and purchase of the specified residential property in accordance with the agreement for sale and purchase irrespective of whether:

- (1) 就該優惠有否引起任何爭議；及

there is any dispute arising from the Benefit; and

- (2) 該指定傢俬公司交付予買方的所有或任何該傢俬是否與該優惠之條款一致。

all or any of the Furniture delivered by the designated furniture company to the Purchaser is in accordance with the terms of the Benefit.

- (g) 賣方、其所有控股公司或其代表不會就該優惠及該傢俬提供保養或作出任何保證或陳述，更不會就該傢俬狀況、狀態、品質、性能或任何該傢俬是否或會否在可運作狀態作出任何保證及陳述。如買方對該傢俬有任何異議或質詢，應直接聯絡該指定傢俬公司。

The Vendor, all its holding company(ies) or any person(s) on its behalf do not provide any maintenance or give any warranty or representation in any respect regarding the Benefit and the Furniture. In particular, no warranty or representation whatsoever is given as to the Furniture’s condition, state, quality, fitness or as to whether any of the Furniture is or will be in working condition. If the Purchaser has any objection or requisitions whatsoever in respect of the Furniture, the Purchaser shall contact the designated furniture company directly.

- (h) 該優惠受其他條款及細則約束。

The Benefit is subject to other terms and conditions.

4(iv). 誰人負責支付買賣該項目中的指明住宅物業的有關律師費及印花稅

Who is liable to pay the solicitors' fees and stamp duty in connection with the sale and purchase of a specified residential property in the development

如買方選用賣方指定之代表律師同時處理有關購買的所有法律文件，賣方同意為買方支付正式合約及轉讓契兩項法律文件之律師費用(只限於買方親自完成轉讓契，但並不適用於買方之提名人或轉購入)。如買方選擇另聘代表律師作為買方之代表律師處理其購買，買賣雙方各自負責其代表律師擬備，完成及登記買賣合約及轉讓契的律師費和支出。

If the Purchaser appoints the Vendor's solicitors to act on his/ her behalf in respect of all legal documents in relation to the purchase, the Vendor agrees to bear the legal cost of the agreement for sale and purchase and the assignment (but only if the assignment is in favour of the Purchaser but not his/ her nominee or sub-purchaser).
