A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.

第 53(2) 條 / Section 53(2)

If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.

In particular, no warranty or representation whatsoever is given as to the condition, state, quality or fitness of the Gift Items or as to whether any of the Gift Items is or will be in working condition. The Purchaser shall not be entitled to raise any objections or inquiries regarding the Gift Items. In the event of any dispute of this Benefit and/or the Gift Items, the decision of the Vendor shall be final.
