 - (a) to accept any submitted tender for any or all of the specified residential properties (herein offered to be sold) at any time before the closing date and time of the tender by amending this Information on Sales Arrangements or any other appropriate means;
 - (b) to reject any tender or withdraw any or all of the specified residential properties (herein offered to be sold) from sale at any time before the acceptance of any submitted tender by amending this Information on Sales Arrangements or any other appropriate means;
 - (c) to sell or dispose of any or all of the specified residential properties (herein offered to be sold) to any person by any method from time to time by amending this Information on Sales Arrangements or any other appropriate means;
 - (d) to adjust the closing date and/or time of the tender for any or all of the specified residential properties (herein offered to be sold) from time to time by amending this Information on Sales Arrangements or any other appropriate means; and
 - (e) to disqualify any non-conforming tenders.
